- How to get the (ACID) Number?
- 4. The importer applies for a shipment-related ACID number on the Nafeza website for an upcoming shipment. To do this, he fills out an electronic form and signs it with the personal e-token. The form contains, among other things, the following information:
- a) Importer details
- b) Exporter details
- c) Product details and shipping details













The ACID number consists of 19 digits (numbers only)

How to get the (ACID) Number?

5. The exporter and the importer then receive the ACID number by email from the Nafeza service provider "MTS" (Misr Technology Services, subordinate to the Egyptian Ministry of Finance)

6. The exporter must then enter this ACID number in all documents and upload it to the CargoX portal.

Should be included on all documents of the shipment













- 1. What is the difference between the ACID Number, CargoX ID Number and Exporter ID Number?
- ACID Number: consists of 19 digits (numbers only, received from CargoX/NAFEZA).

• <u>CargoX ID Number:</u> consists of 36 characters long string, marked in yellow on the picture below which you can find, along with all other details about your company, in your CargoX account under the **My company | Company details**

1. What is the difference between the ACID Number, CargoX ID Number and Exporter ID Number?

• Exporter ID Number:

- 1. Two letter country code (ISO-3166-1) representing the country where the exporter (Shipper) is registered
- 2. Two digits identifying the type of registration number (01-Company Registry 02-VAT)
- 3. The Exporter registration number issued by the relevant authority. Example" US-02-12083143645 (A US based exporter VAT number).











2. What to do if I sent the envelope and need to correct a document?

Create a new envelope with the same ACID number, you don't have to pay another 150USD. It's free of charge











3. What to do If I don't know the 10-digit HS Code?

You don't need to write the complete number, the international 6-8 digits HS Code is enough











4. In which form should we upload the invoice?

The invoice needs to be uploaded in two forms:

1. Pdf- Form: The original invoice

2. Exel- Form: Nafeza Template Invoice
