- The Ministry of Trade of the Republic of Türkiye may request additional information and documents from the importer, producer/exporter, and, if applicable, trader companies to verify the accuracy of the Producer/Exporter Certificate.					
- In case of doubt regarding the accuracy of the information and declarations and supporting documents in the Producer/Exporter Certificate; the Ministry of Trade of the Republic of Türkiye may request information from the customs administration of the country where the producer/exporter and/or trader companies are located, along with the reasons for the doubt and the relevant information and documents. The Ministry of Trade of the Republic of Türkiye may carry out on-site inspections and audits at the facilities of the companies included in the certificate or may request that the customs authorities of the country where the producer/exporter and/or trader are located carry out these inspections.
